L.A. County Library Named Finalist for the 2018 National Medal for Museum and Library Service

L.A. County Library is among the 29 finalists for the 2018 National Medal for Museum and Library Service, and one of just 14 libraries selected nationwide.

The National Medal for Museum and Library Service is the nation's highest honor given to museums and libraries by the Institute of Museum and Library Services (IMLS). For 24 years, the award has celebrated institutions that demonstrate extraordinary and innovative approaches to public service, and are making a difference for individuals, families, and communities.



The L.A. County Library was selected, in part, for its development of the *iCount* equity initiative, which refocuses strategic priorities, making a conscious effort to design services and programs that address the diverse needs of the communities of Los Angeles County.

ELEVATE: Respect. React. Report.

The Board of Supervisors first established the County Policy of Equity (CPOE) Program in 2011, in furtherance of efforts to promote workplace equity, inclusion, dignity and professionalism. Fast forward to more than six years later, and our CPOE Program is still running strong and is successfully achieving its intended purpose. Not only is this true, our Program is also serving as a model process for other jurisdictions.

While all of us who work to successfully administer the Program are very proud of our process, there is always room for improvement. And thanks to our Board, we are excited to unveil a couple of those improvements. Allow us to introduce our new campaign initiative called "ELEVATE: Respect, React, Report." This concept reinforces the importance of rejecting inappropriate workplace behavior and immediately reporting such conduct, so that our County workplaces are ELEVATED to environments that are free from discrimination, harassment, and inappropriate behavior connected to protected categories (including sexual harassment).

We are also excited to introduce a new and improved website which features our ELEVATE campaign and was re-designed with 'user-friendliness' in mind. The website is accessible from any internet connected device (e.g., smartphone, tablet, personal computer, etc.) and supports common operating systems, allowing individuals greater access outside of the workplace. L.A. County Celebrated National Public Health Week

The theme this year was, "Changing Our Future Together," which recognized the importance of building partnerships across County departments, academic institutions, community partners, and residents to ensure that all County residents have the opportunities and resources needed for optimal health and well-being. The Department of Public Health (DPH) hosted a series of events that highlighted our commitments to collective actions that support a diverse workforce, thriving communities, and healthy families.

Our shared commitment to a diverse health workforce: In collaboration with DPH, the Department of Mental Health (DMH) and community partners, Charles Drew University announced the expansion of Pathways to Health, an academic and community internship initiative to build youth leaders and career pathways in the health field for underrepresented youth.

Our shared commitment to promote healthy workplaces and employee well-being: The Department of Human Resources and DPH hosted an Employee Wellness Expo to engage colleagues in shared learning opportunities so that the County's greatest resource, our employees, have the tools needed to support wellness.

Our shared commitment to honor the diverse cultures and experiences of those we serve: DMH and DPH united County staff and community partners to learn from community health workers on how to integrate cultural respect in all our direct service efforts.

Our commitment to prepare residents to support each other during unanticipated emergencies: The Emergency Preparedness and Response Division mobilized County residents to respond during natural disasters and emergencies. Emergency preparedness and hands-only CPR trainings were provided in each of the supervisorial districts.

Our commitment to aligning our work to ensure that everyone has the resources and opportunities to achieve optimal health: DPH convened partners to identify innovative strategies for addressing high rates of infant mortality impacting Black, Native American, and Native Hawaiian families. The event marked the launch of a five-year action plan for closing the gaps in infant mortality rates.

From Temp(LA) to Permanent

Denise Bowen joined the County's Temporary Services Registry (TempLA) on May 5, 2017 – a program headed by the Department of Human Resources. She is a resident of the Fifth District and is currently an Office Support Assistant with the Department of Public Social Services (DPSS) in Lancaster. She will soon be another TempLA employee who gains permanent County employment. She is in the hiring process with the Department of Mental Health (DMH) and will be an Intermediate Typist Clerk. Way to go Denise!

Q: How has TempLA helped you in your situation?

A: Where do I start? TempLA has been a blessing to me. Being selected for this program and having the tools provided helped me be better. Not just for the TempLA program but as a person. I have been working since I was 13 years old and I thought I knew everything about jobs and skills. Now thanks to TempLA, I've enhanced my skills and have become more professional and ready to become a successful County of Los Angeles employee and provide a better life for my son.

Q: About how long were you homeless or housing insecure?

A: Right before I started TempLA, I had been bouncing around with family members for about three years. Then I had my son in 2014. Still bouncing with family members, I was contacted by the Housing Authorities in 2016 and my son and I moved into our place in July of 2016.

Q: What public services did you use while you were housing insecure and what impact did it make on you and your situation?

A: I knew that I had to better my situation. I had just became a mother when I was told I couldn't even have children. There was no way I was going to mess up my chance of being a good mother.

While receiving assistance from CalWORKs, I participated in GAIN and went to a Job Club. An associate told me about the Office Support Assistant position for TempLA through the County of Los Angeles. I applied and was selected. I was so excited. I knew that this was going to be a life changing opportunity for me.

Through this program, I've had the opportunity to assist at the Department of Children and Family Services doing inventory and then went on to DPSS in Districts 67 and 34.

As jobs came up, I applied and continued to utilize the training tools that TempLA provided through Lynda.com and Saba Learning.

One position was for Intermediate Typist Clerk where I was placed in Band 2. In case you're wondering, the typing training material through <u>Lynda.com</u> helped me prepare for the typing test portion of my application.

I am jumping for joy because I am going through the pre-employment process for Intermediate Typist Clerk with the County Department of Mental Health.

Q: Anything else you would like to share?

A: I will forever be humble and grateful for this opportunity. Embrace it. A lot of people have worked hard to give us this opportunity. Use the tools, ask questions, and be the person that represents TempLA to the point where they say thank you so much, you have been very helpful. How do I apply for the job you have?
