You can set up a pre-tax payroll deduction for your commuting expenses such as bus/rail passes, transit vouchers, Metrolink passes, TAP cards, and parking at Park and Ride lots and train stations that are part of your commute to work. Expenses over the pre-tax limit (\$270 per month in 2021*) are deducted from your paycheck on an after-tax basis.
